



## PARADE REGISTRATION FORM

- WHERE:** The parade will commence near the corner of Date Palm Drive and Perez Road in Cathedral City at 5:30 pm. Please check in at registration table no later than 4:30 pm.
- THEME:** "Holiday Lights and Decoration"
- ENTRY DEADLINE:** **Application must be received by November 15th.**  
**All applications must include the signed liability waiver and rules forms.**  
**Limited spaces available.** Once all the spaces are reserved, no more entries will be accepted. No registrations will be accepted on the day of the event.
- SIGNS:** Each entry must have a sign identifying the group or a title of the entry, no larger than 2 feet by 2 feet in size, unless a walking banner.
- MUSIC:** A parade is more fun if it contains music. If it's possible, **add music** to your entry and be sure to indicate if you will have music on the registration form.
- GUIDELINES:** Entries must follow the theme and intent of celebrating the Holiday Season. All participants will be expected to adhere to directions by parade officials. Best area for viewing the parade will be on Perez Road.
- RULES:**
- ★ **For the safety of the spectators and the parade participants, it is not permissible to throw anything from the parade route to spectators. Participants may still hand out candy while walking near the spectators, but it may not be thrown from any vehicle.**
  - ★ **All children under 18 must be accompanied by an adult.**
  - ★ **Santa Claus or Mrs. Claus outfits or replica Santa Claus' are not allowed. The parade will have an official Santa.**
  - ★ **Helmets and safety gear are required for all riding motorcycles.**
  - ★ **Do not invite spectators to approach a moving vehicle/parade entry during the parade.**
  - ★ **NO WATER GUNS, GOPEDS, OR MOTORIZED SCOOTERS/SKATEBOARDS ARE ALLOWED.**
  - ★ **There can be no gaps in the parade. Registrants should be advised that part of the route is uphill at a slight incline.**
  - ★ **All decorations and construction materials must be flameproof according to the manufacturer, or have flame retardant applied to manufacturer's specifications to make materials fireproof.**
  - ★ **All decorated units will have an appropriate number and size of Class ABC fire extinguishers on board.**
  - ★ **Generators may NOT be enclosed without proper ventilation.**
  - ★ **All pets and animals must be on a leash / restrained.**
  - ★ **Lights must be miniature (LED Preferred) of any color.**
  - ★ **You will be assigned a staging area arrival time and entry gate location. It is imperative that each entry arrives at their designated time and place. Entries arriving after 4:30pm will not be allowed to participate.**

**RULES (cont'd)**

- ★ Application must be complete and legible.
- ★ Judging will begin at 4:45pm and awards will be presented after the parade at the festival area.
- ★ If you have a walking group accompanying a motorized entry, this must be noted on the application. They must be staged separately.
- ★ Horses must be bagged or you must provide a cleanup person to walk behind you entry for pickup purposes.
- ★ If your entry is a trailer with pulling unit, both (all) sections of the entry must be lighted. i.e. Truck and trailer, pickup and trailer. The trailer must also be skirted to within 4 inches of the ground.
