# **Community Update**

#### **Upcoming ATP Grant Application – Are you Connected to Win?**

Last December, the City and Coachella Valley Association of Governments (CVAG) embarked on a joint Project to get some previously identified active transportation projects ready for an upcoming Grant Opportunity. Active transportation projects generally are projects that involve pedestrian, bicycle or neighborhood elective vehicle (NEV) modes of travel.

The joint Project, currently underway, has paid for the consulting services of KOA Corporation (KOA) to get the design of five (5) Projects completed up front and ready for the upcoming Active Transportation Project (ATP) Cycle 5 Grant (Grant) deadline of September 15, 2020. (Yes, this is the fifth offering of this ATP Grant which is administered by the Cal Trans and is offering \$440 million of funding across the State, \$11 million available within Riverside County).

The funding for this Grant comes from a combination of Federal, State SB1 and State Highway Account funding. The Proposed Projects in Cathedral City are as shown here:



#### As shown on the map are:

- 1. East Palm Canyon Bike Lane Project
- 2. Cathedral Canyon Drive Bike Lanes, Sidewalk and Multi-Use Trail Project
- 3. Cathedral Canyon Channel East (CCCE) Multi-Use Trail Project
- 4. Gerald Ford Drive Bike Lanes Project
- 5. Date Palm Drive Bike Lanes and Sidewalks Project

Unfortunately, in the past, Cathedral City and other Valley cities have not been very successful securing this Grant in the past four (4) Cycles. Doing some research on what it takes to get a successful grant application, it was found that projects that are <a href="mailto:shovel ready">shovel ready</a> (ready for construction) and had <a href="mailto:good public outreach">good public outreach</a> prior to the application, have the best chance of securing the grant.

So, the first step was for CVAG to award a 75/25 grant to this City for getting the proposed Project's designed up front. The 75 represents CVAG paying for 75% of the design cost and the City paying for 25% of the design costs. The contract for the design work by the consultant was just under \$1 million. Our City Council approved our contribution to the design work in an agreement with CVAG in December 2019. This is well underway in choosing which Projects to submit as they were discussed at the July 22, 2020 City Council Study Session.

The second step in this process is securing good public input, meaning your input. From the onset of this Project, it was planned to have public meetings on the five (5) Projects here at City Hall and at various onsite locations. Traditionally, this would have worked well, and we would have had traditional meetings with water, sodas, handouts and cookies. Unfortunately, the COVID-19 pandemic forced us to cancel the planned public meetings and instead utilize "Virtual Engagement Outreach" by KOA Corporation to secure public comments. We evaluated KOA's past results that were achieved with public input and we knew that this was the way of the future, "Virtual Engagement Outreach." Both the City and CVAG were impressed with how the website was both interactive and informative. So, KOA was tasked with producing a website for us. Launched in early June, "Connect Cathedral City" was available for public comment. 36 responses within the first 48 hours.



As I stated, the City Staff is doing its part in getting the Projects designs done. We ask you to provide us with your input and help the City secure a grant. Go to the website and provide your input on each or all of the Projects. Your input as we stated, is <u>very</u> important as we will include your comments/statistics on the Grant application. 
#### By the Numbers:


As of July 23, Cathedral City had a total of 1,219 confirmed COVID-19 cases and 15 reported deaths. Other Coachella Valley cities are reporting the following:

Coachella - 1,753 cases, 15 deaths

Desert Hot Springs - 621 cases, 8 deaths
Indian Wells - 31 cases, 1 death
Indio - 2,371 cases, 54 deaths
La Quinta - 522 cases. 14 deaths
Palm Desert - 718 cases, 39 deaths
Palm Springs - 653 cases, 24 deaths
Rancho Mirage - 175 cases, 13 deaths

Riverside County has reported 32,813 COVID-19 cases, 637 deaths, and 11,514 recovered cases.
