### It's Election Season in Cathedral City

Elections are at the heart of city government. They are the way in which the people of a community choose their representatives on the City Council – the people who will make the policy decisions that will guide the City into the future. Two City Council members will be elected this November – one in District One and one in District Two. Although voters in Districts 3, 4 and 5 will not be electing City Council members this year, there are a complete list of state and national offices and statewide proposition questions on the ballot in all districts. I encourage every voter to exercise your right to make your voice heard by voting in the November election.

To reduce the spread of COVID-19 and in accordance with State Law, the Riverside County Registrar of Voters will be deploying a new election model for the upcoming November 3, 2020, General Election. This will offer voters more ways and more days to vote safely. Each eligible registered voter for the November 3, 2020, General Election will receive a ballot by mail beginning Monday, October 5, 2020 in accordance with the Governors Executive Order. Riverside County will be providing three voting centers in Cathedral City, one of which will be City Hall. Voters can complete their ballot and mail it in for counting or if they need to vote in person they can use one of the voting centers, which will be open on Saturday, October 31; Sunday, November 1; and Monday, November 2 for 8 hours each day; and on Election Day, November 3 from 7 am to 8 pm. City Hall will also be a drop box location where residents can drop off their mail ballots during regular business hours beginning October 5 through election day. County officials will have 30 days after Election Day to certify the election results. Cathedral City will swear-in the newly elected Council members during a special meeting tentatively scheduled for December 8 and the first regular meeting of the new City Council will occur on December 9.

Indio - 3,380 cases, 66 deaths


La Quinta - 737 cases. 17 deaths


