Community Update

As many of you may be aware, the Police Department has a new Short-Term Vacation Rental Compliance Team under its jurisdiction. The department has hired four full-time compliance officers and one full-time administrative assistant to handle the complaints that derive from the community regarding short term vacation rentals



(STVR) in our city. This will allow for 24 hours a day, 7 days a week service dedicated to short term vacation rental compliance and enforcement.

Each compliance officer is assigned to a patrol team. They are easily identifiable as they will be outfitted in an official uniform with police department insignia. Their uniforms consist of a light blue shirt and navy-blue pants. Each of them will be driving a white Ford Ranger truck with city of Cathedral City markings on both doors as well as the tailgates. The new team will primarily focus on compliance and enforcement of short-term vacation rentals as well as conduct annual inspections of the rentals for license renewal permits.

This compliance team went into full service on November 13, 2020 and they have remained busy handling calls for service regarding short term vacation rentals. As we continue to move forward with this team, their areas of responsibilities will expand over time to include enforcement of other municipal code violations that occur in the city such as illegally parked and abandoned vehicles, issues and concerns involving blight with the goal of beautifying our city.

There are three main ways to reach the STVR compliance team if a community member has a need for their service. The STVR hotline number is (760) 553-1031, the non-emergency police dispatch number is (760) 770-0300 then dial "1"; and finally, anyone with a smartphone or computer may utilize the "GoRequest Mobile App" which can be found at your smartphone's app store or on the city website under the Code Enforcement Department menu.




