# **Community Update**

On March 24, 2021, the City's new Short-Term Vacation Rental (STVR) Ordinance became effective. The STVR Ordinance is codified in the City's Municipal Code as Chapter 5.96 Short-Term Vacation Rental Units.

Under the new STVR ordinance, STVR properties not located within a Homeowners Association (HOA) which permit STVRs or



STVR properties not operating as a Home Share will be phased out by January 1, 2023. Under the STVR Ordinance, no new STVR permits will be issued unless the property meets these requirements. Existing permits that do not meet the requirements will be renewed during this phase out period, but the STVR permit will expire on December 31, 2022.

To address the concerns of the community and enforce the STVR regulations, the City Council approved funding for a STVR Compliance Team. The STVR Compliance Officers are on duty to respond to any and all complaints in a responsive and efficient manner. It is the goal of the STVR Compliance Team to resolve STVR issues with a fair and timely approach.

The STVR Compliance team enforces all provisions of the STVR Ordinance, and in particular, the following new regulations:

- · No outdoor music at any time of the day.
- Prohibited outdoor activities after 10 PM and before 8 am.
- Parking restrictions limiting the number of vehicles to one per bedroom and that all vehicles must be parked on the property.
- Trash shall not be visible 12 hours before or after trash service.
- Complaints related to unpermitted STVR units.

If you have a complaint regarding the condition or operation of the STVR or conduct of the occupants (guests); the City has a 24-hour Vacation Rental HOTLINE for citizens to register complaints.
